1. INTRODUCTION

This part of section 1 of Volume 5 of the MCHW is part of the Specification for Geodetic Surveys. It contains a model Bill of Quantities and a list of provisional items in Appendix 1.

2. PREAMBLE TO THE BILL OF QUANTITIES

2.1 General Directions

In the Bill of Quantities the sub-headings and item descriptions identify the work covered by the respective items, but the exact nature and extent of the work to be performed is to be ascertained by reference to the Drawings, Specification and Conditions of Contract, as the case may be.

The rates entered in the Bill of Quantities shall be deemed to be the full inclusive of the work covered by items specified and shall include the following unless expressly stated otherwise:

- a. Labour and all associated costs.
- b. The supply of materials, goods and associated costs including delivery to the contract area, the Engineer's office or to the Survey advisor and allowing for any wastage.
- c. Plant, temporary works and all associated costs.
- d. The fixing, erecting and installing or placing of materials and goods in position.
- e. Special precautions required to prevent the spread of notifiable contagious animal diseases.
- f. General obligations, liabilities and risks involved in the execution of the works specified or reasonably implied in the documents on which the tender is based.
- g. Establishment charges, overheads and profits.

3. MEASUREMENT

The measurement of work shall be computed nett from the Drawings unless otherwise stated in the Contract.

4. RATES

- a. Items against which no price or rate is entered shall be deemed to be covered by the other rates and prices in the Bill of Quantities.
- b. Where the Survey Advisor requires other survey stations in the control net to be permanently marked these will be charged at the rate for Permanent Ground Markers of the same type as that adopted.
