1. INTRODUCTION AND IMPLEMENTATION

Introduction

1.1 This Standard introduces the August 2008 national amendments to the Specification for Highway Works (SHW), the Notes for Guidance on Specification for Highway Works (NfG), the Highway Construction Details (HCD) and Preparation Bills of Quantities for Highway Works (MMHW).

1.2 The amendments are to be used in the preparation of documents for contracts for the construction, improvement or maintenance of trunk roads including motorways in England, Scotland, Wales and Northern Ireland. (In Northern Ireland, the amended documents will be applicable to those roads designated by the Overseeing Organisation.)

1.3 This amending Standard is to be used in conjunction with:

Implementation

1.4 Contracts for construction, improvement or maintenance of all UK trunk roads including motorways (in Northern Ireland those roads designated by the Overseeing Organisation) shall be prepared using:

- (i) the documents contained in the Manual of Contract Documents for Highway Works (MCHW) March 1998 edition for Volumes 1 and 2, as amended in June, July, August 1998, May 2001, May 2002, November 2002, February 2003, May 2003, August 2003, November 2003, May 2004, November 2004, May 2005, November 2005, May 2006, November 2006, February 2007, May 2007, November 2007, May 2008 and August 2008.
- (ii) the 1991 edition for Volume 3 as amended in August 1993, August 1994, March 1998, July 1998, March 1999, January 2000, May 2000, May 2001, May 2002 February 2003, August 2003, November 2003, May 2004, November 2004 May 2005, November 2005, May 2006 and November 2006.
- (ii) the March 1998 edition for Volume 4 as amended in May 2001, May 2002, February 2003, May 2003, November 2003, May 2004, November 2004, May 2005 and November 2006.

Contracts for which tenders are to be invited after 1 February 2009 shall incorporate by reference the amendments implemented by this Standard, except where the preparation of a contract has reached a stage at which in the opinion of the Overseeing Organisation use of the amendments would result in significant additional expense or delay progress.

1.5 The method of incorporating the amendments to the SHW by reference in tender documents is explained in the Notes for Guidance, Series NG 000, and sub-Clause NG 000.4. The amendment to the Notes for Guidance includes a revised Schedule of Pages and Relevant Publication Dates. A model Preamble is included in the Notes for Guidance. The Preamble to the Specification and the Schedule of Pages and Relevant Publication Dates shall be reproduced unaltered and bound in the Specification with the Numbered Appendices.

1.6 The drawings from the HCD brought into the Contract by reference are to be listed in Appendix 0/4 and dated as appropriate (sub-Clause NG 003.13 and NG Sample Appendix 0/4 in the Notes for Guidance refer).

Superseded Text and Drawings

1.7 Superseded text and drawings in the MCHW Volumes 1, 2, 3 and 4 shall be retained:

- (i) for those schemes for which the Contract has already been awarded using contract documents incorporating by reference the superseded text, and
- (ii) for new schemes for which specific approval has been given to use the superseded text under paragraph 1.4 above.

In these cases, working copies of the MCHW should not have the new amendments incorporated.

1.8 Where working copies of the MCHW are maintained for use on new schemes not covered by the exceptions in paragraph 1.7 above, the superseded pages should be removed and replaced with amended pages (together with all new pages issued).

1.9 Instructions for incorporating the amendments are contained in the published amendment packages.

1.10 The Overseeing Organisations will ensure each office retains an archive copy of MCHW Volumes 0 to 6 incorporating the relevant amendments.
